*J. M. Cantrell, his heirs and assigns,
All that Piece, Parcel and tract of land, situate,
lying and being in the State and County aforesaid,
in Cleveland Township, on waters of Devil Forks,
waters of Middle Saluda River and described as
follows:
Beginning on a white oak, D. Baynes corner, thence
running the condition line made by them, *William
Cox and E. Wilcath* to a dogwood corner, known
as the Turkey corner, thence with the Turkey line
crossing the Devil Fork, to the Old Rag Creek Road,
thence down the meanders of the road, to the end
of the creek, thence crossing the creek, following
the road to D. Baynes line thence with D. Baynes
line, to the beginning corner, and containing 25
acres, more or less,
also, all that Piece, Parcel, or tract of land,
situate, lying and being in the State and County
aforesaid, in Cleveland Township, adjoining the
above described tract of land, and known as
the Dave Bayne Home Place, adjoining lands of
B. P. Cantrell et al. and containing one hundred
and fifty acres, more or less,
