H. L. Sarnomes, his heirs and assigns, all those certain
lots, pieces or parcels of land situate, lying and being
in the County of Greenville, State of South Carolina, about
4 miles Northwest of the city of Greenville, known and
designated as lots nos. 44 (forty-four) and 45 (forty-five)
of "The Coltrough Heights"; according to a Plat thereof made
by R. W. Parker and recorded in office of Register of
Deed Conveyances for said County and State in Plat
Book 2, at Page 95, and having collectively, according
to said Plat the following streets and bounds, to wit,
beginning at a stake in the south corner of Donny-
brook Street and Broadway Avenue and running thence
along Donnybrook Street 46' 25" West 180 feet to a stake;
thence 44' 20" E. 124 feet to a stake on corners of lot no.
46; thence N. 45° 26' E. 180 feet along line of lot no. 46
to a stake on Verden Avenue; thence along said
