to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

*Jas. M. Rupp, his heirs and assigns.*  
All that piece, parcel or lot of land situate in the County and State aforesaid and described as follows:

Beginning at a sweet gum tree near the east bank of branch running in the center line of the branch in a southeasterly direction for approximately 1,280 feet, being the line between the property of Joe Poble and the Greenville Airport, to a poplar tree, thence N. 72-48 E. for 136.3 feet to a stake, thence S. 41-45 E. for 495.8 feet to a stake, thence S. 29-50 E. for 71 feet to the center line of the road, thence in the center line of the road in a westerly direction for approximately 1,260 feet, thence N. 10-29 W. for 695 feet to an iron pin, thence N. 44-02 W. for 434 feet to an iron pin, thence N. 8-53 E. 577.5 feet to point of beginning, containing 25 acres, more or less.
