to it in hand duly paid at and before the sealing and delivery of these presents by the grantee, hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

Thad Adams, and his heirs and assigns.

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, and in Greenville Township, on the west side of Rose Road, and being a part of Lots nos 2 and 25, in Block O, of the property of O.P. Miles, and having the following metes and bounds, to wit:

Beginning at an iron pin on the west side of Rose Road, 230 feet south from Arthur Avenue, corner of lot now owned by Bertrude M.
