at and before the sealing of the e presents by *D. M. Howard*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

*E. M. Howard his heirs and assigns, all that piece or parcel of land in Greenville County, South Carolina, lying and being partly within and partly without the corporate limits of the City of Greenville, County and State aforesaid, on the northeast side of Augusta Street, and being known and designated as lot no. 6 of the Parish and corner property as shown on plat recorded in the C. M. O. Office for Greenville County, in Plan Book E, page 186, and having according to said plat the following meter and bounds, to-wit: Beginning at an iron pin on the north side of Augusta Street, joint corner of lots nos. 6 and 7; thence with joint line of said lot no. 6, 257.6 feet to an iron pin on an alley; thence N. 73-24 W. 311 ft. thence still with alley N. 71-40 W. 80 feet to an iron pin corner of lot no. 8; thence with line of that lot S. 82-07 W. 180.2 feet to an iron pin on Augusta Street; thence with Augusta Street S. 87-03 W. 00 feet to the beginning corner. The grantee herein assumed a \$2000.00 mortgage executed by J. M. Harris with interest from this date.*

Subject, however to the following restrictions which are part of the consideration for this deed and are made for the benefit and protection of the other lots shown on the plat above referred to, which restrictions shall remain effective for a period of (20) years from the date of this deed, to-wit:

- (1) the property herein conveyed nor any part thereof shall not be sold, or otherwise disposed of to negroes.
- (2) The said property shall not be used for any unlawful business nor for anything which would constitute a nuisance.
- (3) The property herein conveyed shall not be re-cut nor subdivided so as to face any other direction than as shown on said plat.
- (4) No building shall be erected upon said property within thirty-five (35) feet of the present line of Augusta Street.
- (5) No building costing less than four thousand (\$4,000.00) dollars shall be erected upon said lot other than sub-buildings appurtenant to a dwelling.

The above described land is the same conveyed to me by *J. M. Harris* on the *4th* day of *Feb.* 1927, deed recorded in office of Register of Meane Conveyance for Greenville County, in Book *113* Page *222* TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said *D. M. Howard, his* heirs, and assigns, forever.

AND *I myself and my* do hereby bind heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said *D. M. Howard* his heirs and assigns, against and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
