Massingale, my heirs and assigns: all that certain piece, parcel or tract of land, situate, lying and being in Greenville County, State of South Carolina, to-wit: the Greenville Belvoir Road, and having the northern water and front to-wit: Beginning at corner on Laurel Creek, corner of 5- acre tract and running thence N. 19 3/4 E. 1/2 Sec. 20 to corner of 5- acre tract; thence N. 34 1/2 W. 1/2 Sec. 20 to corner on Belvoir Road; thence N. 57-10 E. 1/2 Sec. 20 to corner on Belvoir Road; thence S. 27-10 E. 1/2 Sec. 20 to stone; thence S. 71-2 E. 200 to stone; thence S. 71-2 E. 1/2 Sec. 20 to Laurel Creek; thence up said creek to the beginning corner, containing 10- acres, more or less, the remainder of the tract of land conveyed to F.
