Huntington and Dupont Querry, Jr. All my undivided one-twenty-first interest of, in and to the following described premises: All that certain lot of land situate on the north side of Hammond Street, in the City of Greenville, State of South Carolina, having the following meter and bounds: - Beginning at a stake on the north side of Hammond Street, in the center of a ten (10) foot alley, being approximately one hundred fifty and one tenth (150.1) feet from River Street, and running thence with the center of said alley, N. 41-49 E. one hundred forty-three and five one hundredths (143.05) feet to the center line of the C. & G. C.
