in the State, and County aforesaid, in Ward One and on
the West side of Lower Street, in the City of Greenville, and
containing the following number and bounded as follows:
Beginning at the corner of the West side of George
Street and the corner of the said Ward, being
the corner of lot #7 in subdivision of W.C. Cleveland's
property, running thence N. 77. 62-30 E. 61 feet by an
iron fence, corner of lot #7, thence forth line of lot #7
N. 76 W. 140 feet to an iron fence, thence S. 21-30 E. 61 feet
to a wooden fence, on line of lot #7, thence S. 76 E. 140 feet
to the beginning corner and being known as lot #8 in
the Ward, being lots same surveyed by H. D. Nease on
July 3d, 1912 and recorded in office of R. M. C. for Green-
ville County in Vol. "G" at page 44.
The front foot of said tract leads from a 94 foot alley
that runs from Main Street to Park Ave., this front foot
being bordering the rear of Southern side of lots No.
9 1/2 and 8 1/2 and extends along within described lot
