WHEREAS,

on or about the *17th* day of *July* in the year of our Lord nineteen hundred and *twentieth* exhibited *no* complaint in the Court of Common Pleas, for the County aforesaid, against *S. B. Francis*

demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the *17th* day of *July* 192*0*, and such proceedings were had therein as resulted in a Decree

of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described be sold by *S. B. Francis* Master in and for the County aforesaid, on the terms and for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; and the Master, after having duly advertised the said real estate

NOW, therefore, Know all Men by these Presents, That I, *E. Linnam* Master in and for the County of Greenville, aforesaid, in consideration of the sum of *Eight hundred (\$100.00)* Dollars, to me paid by the said *S. B. Francis*

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said

S. B. Francis and his heirs and assigns forever the following described real estate: "All that lot of land situated on the corner of Sullivan and Douglas Streets in the City and County of Greenville, South Carolina, beginning at a point on the North side of Sullivan Street, and runs thence with said Street 58 feet to a stake; thence along Douglas Street West 18.6 feet to a stake; thence S. 87.30 E. 50 feet to a stake; thence N. 8.20 E. 100 feet to the beginning corner being the same land conveyed to Joseph Campbell by J. C. Mitchell, as recited in the 25th day of September 1920 and recorded in Vol. 11, Page 1279. Subject to the right of city."
