on or about the 17th day of July in the year of our Lord nineteen hundred and Twenty-eight exhibited this complaint in the Court of Common Pleas, for the County aforesaid, against Mrs. W. Bothran

demanding relief as to the real estate described in the complaint; and the cause being at issue, came on to be heard on the 3rd day of August 1928, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. Inman Master in and for the County aforesaid, to Mrs. Carter W. Bothran for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. _____)

NOW, Therefore, Know all Men by these Presents, that I, E. Inman Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, and upon receipt of \$3000.00 HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Mrs. Carter W.

Bothran and her heirs and assigns, forever, the following described real estate:
"All that certain Piece, Parcel or lot of land, situate, lying and being in the City of Greenville, State and County aforesaid, on the corner of Boyce and Webster Streets and described as follows: Beginning at a Point at the Southeast corner of Boyce and Webster Streets and running thence in a Southern direction 100 feet along Boyce Street to a Point on Mrs. Fannie Hatcher's line; thence in an easterly direction along Mrs. Hatcher's line 134 feet to Katherine Brocker's lot; thence in a northerly direction along the Katherine Brocker's line 100 feet to Webster Street; thence in a westerly direction with Webster Street 134 feet to the beginning corner."

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said Premises belonging, or in anywise incident or appertaining, and all the estate, right, title, claim and interest whatsoever of the parties to the cause aforesaid, and of each of them in and to the same, and of all other persons right-fully claiming from, under, or any of them.
