COURT OF COMMON PLEAS

TO ALL, WHOM THESE PRESENTS SHALL COME:

Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Daisy B. Cleveland

on or about the tenth day of December in the year of our Lord nineteen hundred and Twenty-eight exhibited her complaint in the Court of Common Pleas, for the County aforesaid, against

P. Mays Cleveland, James N. Cleveland and William Henry Cleveland,

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 13th day of December 1928, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. Inman Master in and for the County aforesaid, to First National Bank of Greenville, S.C. as trustee for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. ...)

NOW, Therefore, Know all Men by these Presents, that I, E. Inman Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said First National Bank of Greenville, S.C. as trustee, a one-half interest in the lot of lands in Bates Township, Greenville County, State of South Carolina, in the village of Marietta, adjoining Slater, in the State of South Carolina, and having the following boundaries as shown on the plat made by J. E. Surrine & Company, dated September 5th, 1928,

Beginning: At an iron pin on a road 24 feet wide which it is proposed to lay out through the property of Slater Manufacturing Company and J. Norwood Cleveland and the late P. Mays Cleveland, and running thence with the line of Slater Manufacturing Company N. 81-55 E. 385 feet to an iron pin; thence S 40-21 W 67.9 feet to an iron pin; thence N 85-47 W 231 feet to an iron pin in the 64 foot road, thence with the road S. 55-25 E. 224.8 feet to the beginning corner. The other undivided one-half interest in the lot has been conveyed to grantee by J. Norwood Cleveland.

This deed is made for the purpose of securing a proper site for the Slater Marietta School, and J. Norwood Cleveland and also the heirs of P. Mays Cleveland for any advances they make for purpose of building the said Slater-Marietta School in Marietta School District No 12-B until all such advances made by them are fully paid with interest at 6 per cent. It is understood and agreed that the trustee shall hold the property until such time as the lender of the money notify the trustee that the loans have been repaid, at which time the lot above described shall be conveyed to

Marietta School District, through its trustees upon the following conditions: to be used exclusively for school purposes and to be known as Slater Marietta School. If not so continuously used for school purposes or if used for any other purpose, or if the same be changed, then the above land shall revert to the grantor, its successors and assigns.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said Premises belonging, or in anywise incident or appertaining, and all the estate, right, title, claim and interest whatsoever of the parties to the cause aforesaid, and of each of them in and to the same, and of all other persons right-fully claiming from, under, or any of them.

TO HAVE AND TO HOLD, all and singular the premises before mentioned, unto the said First National Bank of Greenville, S.C. as trustee, its successors and assigns forever.
