Pitman.on or about the 31st day of October in the year of our Lord nineteen hundred and Twenty-nine exhibited themselves complaint in the Court of Common Pleas, for the County aforesaid, againstJannie Hughes, Carl Hughes, Hortense Hughes and Ruthel Hughesdemanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 8th day of November 1929 and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinabove mentioned and described, be conveyed by E. Inman, Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, and upon receipt of \$500.00 HAVE GRANTED conveyed and released, and by these presents, DO GRANT, convey and release unto the said

T. D. Pitman, the following described real estate: All that certain parcel of land tract of land situate and lying in South Carolina Greenville County, Highland Township, on branch waters of Wild Cat Creek and designated as Lot no 2 of the real estate of L. Walker Moon, deceased, as shown by a plat prepared by St. O. Morrow, Aug 1927 and filed as a part in the records in the case of A. Mton et al, vs Decatur Hughes, et al, in the office of Clerk of Court, Common Pleas, and having the following metes, bounds courses and distances to wit.

Beginning at a point in the intersection of the road leading from Highland to O'Neal, with a cross country road and running thence N. $71\frac{1}{2}$ E. 3.95 chs to a stake, thence N. 39 E. 12.90 to a stake in the line of St. D.
