KNOW ALL MEN BY THESE PRESENTS, That The Estowah Realty Corporation

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville, In the State of South Carolina for and in consideration of the sum of Ten DOLLARS,

and other valuable considerations

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee..... hereinbefore named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto T. J. Simmon, his heirs and executors all that certain piece, parcel and lot of land in the County and State above said, being known and designated as lot No. one U. of Paris Valley Park According to plan thereof recorded in the R. M. C. Office for Greenville County in plan book A, pages 19 and 20. Reference to said plan being made for a more complete description of said lot see plan Vol. 107, page 356, Vol. 116, page 42.

as a part of the consideration for this conveyance the grantee further agrees to pay according to its terms a certain sum to secured by mortgage contract the original described as executed by W. D. Workman to J. M. Richardson, dated June 29th, 1926, in the sum of \$300.00 paid Mortgage being recorded in the R. M. C. Office for Greenville County, see Vol. 177, page 78.

In accepting this deed the grantee agrees that the following restrictions shall be covenants running with the land and that in the event of violation of any of them, the property herein conveyed shall revert to the immediate grantor.

(1) No lot in this subdivision shall be sold, leased or rented in any manner, directly or indirectly, by any title either legal or equitable to any person not of the Caucasian race, nor to any corporation of which any stockholder shall be other than of the Caucasian race.

(2) The owners of all lots in this subdivision shall provide for the disposal of sewage from his lot or lots by means of septic tanks of an approved type (where sewage is not accessible) and no outside toilet shall be built in any easement as and shall be reserved to use a strip of ground for the purpose of installing and maintaining telephone and electric lines, water and gas pipe.

(3) No fence shall be permitted to be maintained on any lot in this subdivision.

It is understood and agreed that the grantee his heirs or executors shall have the privilege of tapping on to the water line to be laid for the service of this subdivision without additional cost.

TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee..... hereinabove named, and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee..... hereinabove named, and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
