to it in hand duly paid at and before the sealing and delivery of these presents by the grantee herein named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto J. J. Gwynne, his heirs

all that certain piece, parcels and lot of land in the County and State aforesaid, being known and described as Lot No six (6) of Block (5) Blue, of Section "A" Emanuel Estates, according to a plat thereof recorded in the Office of the Register of Deeds for Greenville County, in Part Book 34, Pages 21 and 24, reference to said plat being made for a more complete description of said lot. In accepting this Deed, the Grantee herein agrees that the following restrictions are concurrent with the lands, and that in the event of violation of any of these, the property herein conveyed will revert to the immediate grantor:

(1) The grantee and himself, his heirs and assigns never to publicly advertise for sale any lot or lots in this subdivision at a price less than that at which the grantor is advertising similar lots in said Emanuel Estates.

(2) No lot in this subdivision shall be sold, leased, or rented in any manner, directly or indirectly, by any title either legal or equitable, to any person, not of the corporation, nor to any corporation or to any stockholder shall be other than of the corporation.

(3) No insurance shall be permitted to be maintained on any lot in this subdivision.
