E. 9.98 to iron pin, thence S. 79° 12' 2.25 to iron  
pin on Laurens Road, thence with said road  
N. 12° 34' 4.35 to iron pin; thence S. 42° 13' 21.58 to  
stone; thence S. 64° 18' E. 4.20 to a stone; thence  
N. 72° 40' 6.56 to a stone; thence N. 23° E. 9.45 to a  
stake to the beginning corner, and containing
