The South Carolina National Bank of Charleston
all that certain piece, parcel or lot
of land situate, lying and being in the
County of Greenville State of South Carolina
in the subdivision known as *Cherokee Park*
and designated as lot no 1 of the *E. C. Cass*
property according to a revised plat of
same made by *C. M. Furman*, May 1st, 1924
and recorded in the R. M. O. Office for
Greenville County in Plat Book 2 at page 227,
having the following metes and bounds, to wit:
Beginning at an iron pin on
the northeast side of *Howell Avenue*, which
iron pin is 75 feet from the north eastern
intersection of *Saluda* and *Howell*
Avenues and running thence N. 62-32 St.
17.2 feet to an iron pin in the south-
eastern side of a 15-foot alley; thence along
the south eastern side of said alley N.
27-28 E. 50 feet to an iron pin, the rear
point corner of lots nos 1 and 2; thence
along the joint line of said lots S.
62-32 E. 17.2 feet to an iron pin in the
line of *Rescue Avenue*; thence along the
north western side of *Howell Avenue* S.
27-28 St. 50 feet to the point of beginning.
