All of our right, title and interest of  
any kind in and to those two certain par-  
cels of land in the City of Greenville, State  
and County aforesaid, and fully described be-  
low by metes and bounds, according to a survey  
made on January 1928, whether our right, title  
and interests be derived from either the Estate  
of Dr. Samuel Marshall or the Estate of Mrs.  
Eliza Marshall or both. The following is

No. 1. Beginning at a stone post on Buncombe  
Street, and running thence N. 48-06 E. 542.6 to a  
pipe on Marshall Avenue; thence S. 64-34 E. 272.9  
along Marshall Avenue to a fence post; thence  
S. 48-14 W. 683.7 to a stone post on Buncombe  
Street; thence with Buncombe Street N. 33-42 W.  
252.7 to the beginning corner.

No. 2. Beginning at a pipe on Marshall Avenue  
and running thence N. 48-06 E. 700.8 to a  
pipe on St. Park Avenue; thence S. 76 E. 71.4  
along St. Park Avenue to a pipe; thence S.  
38-38 E. 164.9 to a st. o. corner; thence S. 2-05 E.  
153 to a pipe; thence S. 86-32 E. 174.3 to a  
pipe; thence S. 28-07 W. 498.5 to a stake on  
Marshall Avenue; thence with said Marshall  
Avenue N. 66-11 W. 698.3 to the beginning corner.
