the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said South Carolina National Bank, its successors and assigns;

All that piece, parcel or lot of land situate, lying and being in Greenville Township, County and State aforesaid, on the Paris Mountain Road, near the City of Greenville, known and designated as lot No. 60, as shown on plat of the Perry Estate, of record in R. M. C. Office for Greenville County, S. C. in plat Book F, page 127 and having according to said Plat, the following notes and bounds, to-wit:

BEGINNING at an iron stake on the Paris Mt. Road, joint corner of Lots 60 and 61 and running thence with the Paris Mountain Road, N. 5-17 W. 80.5 feet to an iron stake joint corner of lots 59 and 60 thence S. 58-30 W. 230 feet to an iron pin; thence S. 31-30 E. 75 feet to an iron pin, joint corner of lots 61 and 60; thence along line of lot No. 61, N. 58-30 E. 133 feet to the beginning corner on Paris Mountain Road.

Also that other piece parcel or lot of land situate, lying and being on the north side of Clayton Street, known as lot No 63 as shown on plat recorded in Plat Book "F", Page 127 in R. M. C. Office for Greenville County, and being more particularly described as follows:

BEGINNING at an iron stake on the north side of Clayton Street joint corner of Lots Nos. 62 and 63 and running thence N. 31-30 W. 150 feet to an iron stake; thence S. 58-30 W. 50 feet to an iron stake; thence S. 31-30 E. 150 feet to an iron stake on Clayton Street; thence N. 58-30 E. 50 feet along Clayton Street; to the beginning corner.

It is distinctly understood that the grantee herein takes this property subject to a mortgage of \$4350.00 together with interest executed by Leila Hayes to A.D.L. Barndale, and recorded in the R. M. C. Office for Greenville County in Volume 163, page 173, and which has been assigned to the Grantee; the grantee does not assume payment of it, and the above mortgage shall not merge, but shall remain open for the protection of the grantee.
