To have and to hold all and singular the premises before mentioned unto the said J. G. Saunders,

J. A. Saunders Jr. and R. B. Seaton and their heirs and assigns forever, subject however, to the following restrictions and conditions to-wit:

1. The lot of land hereby conveyed shall be used exclusively for residential purposes for white persons only (except as to servants of occupants) and shall never be sold, rented or otherwise disposed of to any person wholly or partly of African descent. To used in any manner which may render neighboring property less desirable for residential purposes.

2. No residence (other than out-buildings appurtenant to dwellings) costing less than five thousand dollars (\$5,000.00) shall be erected thereon prior to January 1, 1942.

3. The Grantor reserves to itself and its successors the right to authorize the placing, maintaining, repairing and replacing of gas, water and sewer pipes, telephone, telegraph, light and power lines, and any other instrument of public utility over or under any street, alley, park or lot at any time, without compensation to any lot owners, except that the premises shall be left in as good condition as found.

4. No surface closet or cesspool shall ever be used on said land; but only septic tanks or other sanitary sewers; and all occupants of said land shall be governed by such reasonable sanitary rules and regulations as may be adopted from time to time by a majority of the owners of lands in said "North Hills".

The purchase price of said land has been reduced materially because of the foregoing conditions, which are not conditions subsequent, but are to be deemed covenants running with the land and binding all owners and occupants thereof. They may be enforced by appropriate proceedings by any owner or occupant of any land in North Hills as well as by this Grantor, since they are for the benefit of all persons in the neighborhood, by accepting this deed, each grantee binds himself and his heirs and assigns to comply with all of said conditions.
