I now allow and give by these presents, that A. M. Hayes in the State aforesaid, for and in consideration of the sum of One and Ten Dollars and other valuable considerations to me paid by the Southern Public Utilities Company, a corporation, in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold, vend, released, and the said Southern Public Utilities Company, a corporation, its successors and assigns, the right, privilege, and easement to go in and upon that tract of land lying, situate and being in the State aforesaid on the West side of Butcombe Road, and adjoining property of P. P. Taylor on the North and Dr. G. W. Williams, (North and South) and to construct and maintain in, upon and through said premises in proper manner, with poles, wires and other necessary apparatus and appliances, a pole line for the purpose of transmitting power by electricity, together with the right at all times, to enter upon said premises for the purpose of inspecting said lines, and making necessary repairs and alterations thereon.

Provided, however, that the grantor herein reserves the right to require the grantee to change any pole that might hereafter be in the way of streets or sidewalks, that might be laid off in any subsequent development of the property, and provided further that the said poles shall be placed adjacent to the edge of the road.
