Ross, Ford Thackston, Christine Thackston, Louise Thackston and Rachel Thackston of said County and State, in consideration of the sum of \$1000.00 and of the sum of 1862.00 Five dollars to us in hand paid by the Southern Power Company the receipt whereof is hereby acknowledged, do hereby grant unto the said Southern Power Company its successors and assigns, the right, privilege and easement to go in and upon that tract of land situated in said County and State, bounded by lands of J. S. Watkins, Smith Griffin, Col. F. W. Smith, and League, and others and to construct and maintain in, upon, and through said premises, in a proper manner, with poles, towers, wires and other necessary apparatus and appliances, a line for the purpose of transmitting power by electricity, together with the right, at all times, to enter upon said premises for the purpose of inspecting said line and making necessary repairs and alterations thereon; together with the right to keep said right-of-way clear of all structures for the space of thirty-four feet (34') on each side of the center of said power line, with the further right to cut away and keep clear of said line and wires all trees or other like obstructions that might in any way endanger the proper operation of same.
