(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

all that certain piece parcel or lot of land, on  
the East side of South Main Street, in the City of  
Greenville, County and State aforesaid, and having  
the following westerly and southerly to westerly  
dimensions:

A tract of land lying upon the east side of  
South Main Street at the northeast corner of the  
lot of J. W. Stace, Jr., being approximately 104 feet long  
from the southeast corner of N. Main and E. Basle  
Street, and running thence with the line of said  
lot backwars 70-13-0 ft. 155 feet 5 in. more or  
less to an iron pipe, corner of lot heretofore con-  
veyed to H. L. Stace, Jr., November 1, 1927, bounded  
with the line of said lot 70-13-0 ft. 155 feet 5 in.  
to a point of the lot heretofore conveyed by me  
to Mabel L. Stace, Jr., being with line of lot of metal  
floors 71-10-2 ft. 155 ft. 5 in. more or less  
to an iron pipe they east side of N. Main  
Street 30 feet from the corner of E. Basle Street  
thence with N. Main Street 8-19-39 ft. 54 feet 9 in.  
to the beginning corner.

Subject, however to all mutual rights of  
way, other ten feet at the rear of said lot
