A right-of-way sufficiently wide to construct the road as planned, and not less than 25 feet wide on each side of center line of road, on and over all lands, lying along the road, known, as Route No. 211 at any point or points lying between the Lisleland Name of Place

and See Highway Name of Place which I (or we) may own in whole or in part, for the purpose of constructing and maintaining said highway, with the bridges and causeways thereon.

Together with, all and singular, the rights, members, hereditaments and appurtenances thereto belonging, or in any wise incident to or appertaining. It is agreed that any buildings or fences to be moved from the right of way will be moved at the expense of said County or State.

TO HAVE AND TO HOLD, all and singular, the said right of way and the rights hereinbefore granted, unto the said State Highway Commission, its successors and assigns, so long as the same shall be used as part of the highway system of this State or Nation.

A right-of-way sufficiently wide to construct the road as planned, and not less than 25 feet wide on each side of center line of road, on and over all lands, lying along the road, known, as Route No. 211 at any point or points lying between the Lisleland Name of Place
