W. Freeman, now owned by him or which he may hereafter acquire.

12) The said C. W. Freeman, on his part, here by releases the said Nelle Boland Freeman from any right or claim upon her in any manner whatsoever as wife, and agrees to live forever hereafter separate and apart from the said Nelle Boland Freeman, and in consideration of the conditions set forth here to fore and in consideration of five (\$5) Dollars to him in hand paid at and before the sealing of these presents, the said C. W. Freeman hereby releases and renounces any right or claim (that he may have now to any property, which the said Nelle Boland Freeman may own, either real or personal, or that she may hereafter in any manner inherit or acquire, and to make no claim against the said Nelle Boland Freeman for any financial or property consideration in any manner, growing out of their said marital relation or otherwise, forever.

It is the purpose of this instrument and agreement to settle all claims and liabilities forever, growing out of the relationship as husband and wife, of the parties hereto.

To the faithful and just performance of the above articles of agreement, the said C. W. Freeman and the said Nelle Boland Freeman, hereby binds themselves, their heirs, administrators, executors and assigns, forever, this 22nd day of May 1929.
