NOW, therefore, Know all Men by these Presents, That I, E. Inman Master in and for the County of Greenville, aforesaid, in consideration of the sum of Thirty Three Hundred (\$3300.00) Dollars, to me paid by the said William H. Bahan

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said William H. Bahan, the following described real estate:

All that certain piece, parcel or lot of land situate on Hampton Avenue in Ward One of the City of Greenville, County and State aforesaid, and having the following metes and bounds according to a survey made by W. M. Rast, October, 1929—Beginning at an iron pin on Hampton Avenue corner of Lot of Jennie C. Stow and running thence with line of her Lot N. 32-35 E. 136 feet to iron pin thence S. 51-30 E. 43.2 feet to iron pin; thence S. 30-30 W. 136.6 feet to iron pin on Hampton Ave; thence with Hampton Ave. N. 49-16 W. 43.7 feet to the beginning corner, and being all of the land described in deed of I. W. Jacobi to Carrie T. Goodwin, dt ed Sept. 30, 1910 and recorded in deed Book Vol. 6, at Page 177, except lot conveyed by the said Carrie T. Goodwin to Jennie C.
