located in the city of Greenville and being a part of the  
city block property, and having the following lines,  
westerly and southerly, to-wit: Beginning at a stake  
corner on Smith Street and New Cut Road, and run-  
ning thence in a Northerly direction with Smith  
Street 153 feet and thence to a stake, corner of lot #10,  
thence with said line in an Easterly direction 63'  
feet to a stake, thence in a Southerly direction with  
line #10, 154 feet and 6 inches to a stake and  
New Cut Road, thence in a Westerly direction with said  
land 5 feet to the beginning corner, and being known  
as lot #11, according to the plat of the City Block property.  
Also, all that certain piece, parcel or lot of land  
situate, lying and being near the city of Greenville
