Batson, do hereby consent to the operation and maintenance of said sewerage system and any replacements thereof, and to the emptying into said Reedy River by Brandon Corporation, its successors or assigns, of sewerage, dyes, chemicals, water and refuse, and do hereby release said Corporation, its successors and assigns, from any damages which may have resulted, or which may hereafter result, therefrom to that certain tract of land described in the deed from Jasper T. Batson to Jesse N. Batson, dated December 1, 1919, recorded in Deeds Volume 64, at page 249, of the R. M. C. Office for Greenville County, a portion of said land having thereafter been conveyed by Jesse N. Batson to Houston L. Batson by deed dated January 9th, 1930, recorded in Deeds Volume 133 at page 228.
