to me in land paid by the SOUTHERN PUBLIC UTILITIES COMPANY, the receipt whereof is hereby acknowledged, do hereby grant  
unto the said SOUTHERN PUBLIC UTILITIES COMPANY, its successors and assigns, the right, privilege, and easement to go in and upon the certain tract  
or lot of land situated in said County and State located on the Lawrence Road near

this city of Greenville, S.C. (This being the property  
formerly belonging to the S.C. Inf. Co., (the latter  
the Conch Cotton Mills and Gullwater Inf. Co.)

and to construct and maintain in, upon, and through said premises, in a proper manner, with poles, wires and other necessary apparatus and appliances, a line for  
the purpose of transmitting power by electricity, together with the right at all times to enter upon said premises for the purpose of inspecting said lines and  
making necessary repairs and alterations thereon; together with the right to ~~cut away~~ and keep clear of said lines ~~all trees and other~~ obstructions that may, in  
any way, endanger the proper operation of the same.

It is understood and agreed that the Southern Public Utilities  
company has the right to trim any trees necessary to keep their  
lines clear, but that no trees shall be cut down without the written  
consent of the said owners. This right of way is subject to a lease  
heretofore executed to the Westboro Weaving company and the purchase  
option given them. Said Southern Public Utilities company hereby agrees  
that in case the Gullwater Syndicate should wish these poles changed, that  
they will change the location of the poles at cost, the expense of same to be borne by  
the Gullwater Syndicate.
