Public Utilities Company, a corporation in the state aforesaid, the receipt whereof is
hereby acknowledged, have granted, bargained, sold and released unto the said Southern
Public Utilities Company, a corporation, its successors and assigns the right, privilege and
easement to go in and upon that tract of land in the state and county aforesaid, lying
along a road running from Greenville S. C. known as the Anderson Road,

and to construct and maintain in, upon, and through said premises, in a proper manner, with poles, wires and other necessary apparatus ^{along said highway} and appliances, a line for
the purpose of transmitting power by electricity, together with the right at all times to enter upon said premises for the purpose of inspecting said lines and
