Piedmont Corporation,

All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, about five miles from Greenville County Court House, on the west side of Augusta Road as now located, on the waters of Brushy Creek, containing one hundred fifty-seven acres, more or less, and bounded by lands of Julia D. Charles, Sam Rosemond, Henry Mason and Sornie Mason, and having such courses, mates and bounds as are shown on a plat made by R. E. Dalton, C. E., dated May 1923, to which reference is hereby craved.
