All that Certain lot or parcel of land situate in Greenville Township, County and State aforesaid, just beyond the incorporate limits of the City of Greenville, lying on the north side of Prentiss Ave., and being known and designated as lot no. 4 Block 7, as is shown by plat recorded in the R. m. c. Office for Greenville County in plat Book C, at page 176, and according to said plat recorded as follows:

Beginning at iron pipe on North side of Prentiss Ave., 65 feet from Northwest corner of Prentiss Ave. and Jackson Street, and running thence along West line of lot no. 2, N. 44-33 W. 180 feet to pine on 16 ft. Alley; thence along South side of said alley S. 45-27 W. 65 feet to pine at corner of lot no. 6; thence along line of lot no. 6 S. 44-33 E. 180 feet to pine on North side of Prentiss Ave.; thence along said side of said Avenue N. 45-27 E. 65 feet to the beginning corner.
