All those certain pieces, parcels or lots of land
situate, lying and being in the City and County of
Greenville, State of South Carolina, off the Washington
Road, being 300 feet and designated as Lot 50, and
one-half of Lot 51 (being the Western Half) according
to plat recorded in R. M. 6 Office for Greenville County
in that book a page 333, said lot 50 having a
frontage on Washington Road of 50 feet and running
back in parallel lines of 175 feet; said Western
Half of Lot 51 having a frontage on Washington Road
300 feet and running back in parallel lines adjoining
