NOW, Therefore, Know all Men by these Presents, that I, E. Inman  
Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, and upon receipt of \$400.00

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Marion Davis Connor

All the right, title and interest of the minor  
defendants, Wofford Fletcher Davis and Martha  
Lillian Davis, the same being an undivided four-  
ninths (4/9) interest in and to the following  
described real estate:

"All that certain piece, parcel or lot of land, situate,  
lying and being in the State of South Carolina,  
County of Greenville, and in Greenville Township,  
and being known and designated as Lot No. 8 of  
Block A, of a subdivision known as Augusta Court,  
and having, according to a plat thereof recorded  
in the R. M. C. Office for Greenville County in Plat  
Book I, Page 124, the following metes and  
bounds, to-wit:

Beginning at an iron pin on the north side of  
Augusta Court Street, joint corner of Lots 7 and 8,  
which point is approximately 276 feet west of the  
intersection of Augusta Road and Augusta Court  
Street, and running thence along the north side  
of Augusta Court, S. 52-03 N. 80 feet to an iron  
pin, corner of Lot No. 9; thence along the line of  
Lot No. 9, N. 37-57 N. 318.9 feet to an iron pin in  
line of property of C. W. Carpenter; thence along the  
line of that property, N. 55-30 E. 80-04 feet to an
