C., being all of Lots Nos. 37, 38, 42, 43, 44, 45, 46, 47, 48; the western portion of Lot No. 39, the eastern portion of Lot No. 41; and small strip in rear of Lots Nos. 39, 40 and 41, as shown on plat of the property of B. Perry Edwards, prepared by R. E. Dalton, Engineer, May 1920, which said plat is recorded in the R. M. C. office for Greenville County, S. C., in Plat Book "F", at page 143, revision of Lots Nos. 39, 40 and 41, being recorded in Plat Book "F", at page 49 and having, according to said plat, the following metes and bounds, to-wit:-
