State of South Carolina, County of Greenville.

Know all men by these Presents: That I, Henry Schwiers, of said County and State for and in consideration of the terms, conditions and privileges here-inafter expressed and the sum of One Dollar (\$1.00) to me in hand paid by Greater Greenville Sewer District Commission of Greenville, S. C., the receipt whereof is hereby acknowledged, do hereby grant unto the said Greater Greenville Sewer District Commission, its successors and assigns the right, privilege and easement to go in and upon that tract or lot of land situated in Greenville Township, in said County and State, beginning at a point in the property line between August Schwiers and myself, thence in a northerly direction across my property 410 feet more or less, to the line between my land and the land owned by H. C. Alexander.

and to construct, maintain in and upon and use in and through said premises, in a proper manner, with necessary apparatus and appliances such as machinery, air vents, manholes, blow off connections and any and every necessary and proper attachment, pipe lines for sewerage purposes through the premises above described together with the right at all times to enter in and upon said premises for the purpose of inspecting and making necessary repairs and alterantions thereon of said lines, together with the right to cut away and knep clear of said pipe lines with the all trees and other obstructions that may in any way endanger the proper operations of same.

It is understood and agreed that the easement here in granted shall extend throughout the property of the grantor about 410 feet, and shall be of such width as the grantee shall deem necessary for the purpose herein specified, and that the damage for which Greater Greenville Sewer District Commission may be held liable shall be confined to that arising from the use of this strip only, and nothing beyond.

It is further agreed and understood that this easement is to be used only during the construction or repair of said pipe line and with the exception of the right of Greater Greenville Sewer District Commission, its successors and assigns, agents, servants and employees to inspect said pipe line and to enter at any point and make repairs, the owner has the same right as he now has to cultivate and use the land.

It is furly understood that all pipes will be laid at sufficient depth below the present surface of the ground to allow unobstructed cultivation, except at manholes, branches, plainly defined ditches or gullies.

It is further agreed and as a part of this consideration hereof that the grantor herein, his heirs and assigns, may make taps or connection with said pipe lines, at his own expense, to serve not more than the same number of dwellings now on the premises, provided, however, that such connections or taps be made only under the rules and supervision of the engineers representing Greater Greenville Sewer District Commission or their successors.

It is futher understood and agreed that in case of future damage to crups or property due from accident in said pipe lines that Greater Greenville Sewer District Commission shall pay reasonable damage therefor.

The payment and privileges above specified are hereby accepted in full settlement of all claims and damages for said easement.
