Lessee, during the term of this lease or any extension thereof, is given the right to sublet or assign all or any part of its rights in and to said premises.

It is further the agreement of the parties that Lessee has and is hereby given the right to cancel this lease, and if Lessee desire so to do Lessee shall give 10 days' written notice to Lessor and designate a particular rental due date upon which such cancellation is to become effective. In said event lessee further agrees, as a consideration for said cancellation, to pay to Lessor the total sum of one Dollars.
