all that piece, parcel or lot of land in **Greenville** Township, Greenville County, State of South Carolina, **being part of lots 22 and 23 in subdivision known as Eastover, as shown on plat** in plat book F, page 42, having the following metes and bounds: **beginning at a stake on the north side of Beechwood Avenue, 178.2 feet east from corner of lot No. 22, at corner of lot of Mattie E. Harrison thence in a north-easterly direction with Harrison line 216 feet, more or less, to stake on ditch which stake is 137.5 feet from corner of lot No. 21; thence N. 30 W. 60 feet to stake; thence in a south-westerly direction 216 feet, more or less, to stake on Beechwood Avenue, thence with Beechwood Avenue 60 feet to beginning.**
