In the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, its successors and assigns all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina,

more definitely described as follows:

Lot on the east side of Academy Street, between Washington Street and McRee Avenue, and beginning at a point on said Academy Street 100 feet from McRee Avenue, and running thence N. 25-45 E. 50 feet, thence S. 70-45 E. 38.6 feet, thence S. 22-40 W. 50 feet to a stake; thence N. 70-45 W. 41 feet to the beginning corner, being the same lot conveyed to E. G. Goddard by Martha G. Goddard by deed dated February 11, 1920, recorded in the R. M. Co. Office for Greenville County in Volume 57, page 504.

Also: Lot on the south side of West Washington Street, beginning at an iron pin on Washington Street, 100 feet from lot owned by Meredith, formerly owned by Mary E. Henry, thence with Washington Street 50 feet to iron pin; thence S. 27 W. 150 feet to iron pin on 20-foot alley; thence with said alley S. 57 W. 50 feet to iron pin corner; lot owned by Bruce B. Still; thence with line of Bruce B. Still N. 27 E. 150 feet to the beginning corner on Washington Street.
