All that certain piece, parcel or lot of land situate lying and being in the State and County aforesaid, beginning at the northwest corner of lot no 60 and running thence with the north line of said lot N 67-55 E. 150 feet to a corner, thence N 19-45 W 100 feet to a corner, thence S 66-55 W 150 feet to a corner on Echo Drive thence with Echo Drive S 19-45 E. 100 feet to the beginning this lot being known and designated as lot no 62 on plat of Bassie Head development.
