thence S. 43- W. 6.50 to a pine 3x0; thence S. 61 W. 19.60 to a stone 3x0; thence S.
24 E. 17.60 to a stone 3x0; thence N. 63 1/2 S. 15.30 to an iron pin 3xn; thence N. 2 W.
15.50 to an iron pin 3xn; thence N. 30 E. 6.75 to an iron pin 3xn in said branch; thence
up the meanders of same to the beginning, containing 36 acres, more or less, and being
