in City View, on east side of Parker Avenue, and having the following courses and distances beginning at an iron pin on Parker Street, thence S. 12 1/2 E. 113 feet with Parker St. to an iron pin; thence N. 63 1/2 E. 160 feet to iron pin; thence N. 13 E. 92 1/2 feet to iron pin; thence S. 66 1/2 W. 206 feet to beginning corner, being lots 5 and 6 as shown on a plat and survey by W.
