All that certain piece, parcel or lot of land situate lying and being in the State and County aforesaid, in O'Neal Township, lying on the public road leading from Chick Springs to Westellers Mill.

Beginning at an iron pin South of said road and running N. 43° 30' W. 629 chains to an iron pin in the center of the new road; thence S. 71 $\frac{1}{2}$ E. 60 links to an iron pin in East edge of the old road; thence N. 35 E. 17.41 chains to iron pin in edge of gully near fence corner; thence N. 65 $\frac{1}{2}$ W. 16.25 chains to iron pin in the woods by fence corner; thence N. 34 $\frac{1}{2}$ E. 3.18 $\frac{1}{2}$ chains to a stone; thence East 18.71 chains to a stone in the edge of the woods; thence South 20.37 chains to iron pin near red oak; thence S. 48 $\frac{1}{2}$ W. 1176 chains to a stone near a scrub oak; on the North side of the road; thence S. 74 $\frac{1}{2}$ W. 656 chains to the beginning corner, containing Twenty eight and 50/100 acres, more or less, according to survey and plat made by W. A. Christopher Surveyor, November 26th, 1917, and is part of a tract conveyed to W. M. Bishop by A. H. Miller Trustee December 7th, 1915, and recorded December 14th, 1915 in Volume 38, at page 306.

Bounded on the North by lands now or formerly Lawrence Green and Robert Pollard; on the East by W. G. Southern and W. T. Vaughan, on the South by S. L. Bishop, on the West by W. M. Bishop, and John Greer.

This being the same tract of land conveyed by P. V. Vaughan to G. V. Hanna by his deed dated the 12th day of March 1919, recorded in R. M. C. office of Greenville County on March 18th, 1919, in book 34, at page 457, and from G. V. Hanna to J. P. Fleming recorded in the R. M.
