the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the Corporate limits of the City of Greenville, S.C. and being known and designated as a portion of Lots Nos. 24 and 25 as shown on Plat of property of W. C. McDaniel, which plat is recorded in the R. M. C. office for Greenville County in Plat Book "F", page 188, and being more particularly described as follows:

Beginning at an iron pin on the Western side of McDaniel Avenue, which point is 93.2 feet South of the Southwestern corner of McDaniel Avenue and Camille Street, and running thence N. 88-24 W. 197.5 feet to an iron pin in the rear of line of Lot No. 14, which point is 90.72 feet South of the Southern side of Camille Street; thence with the rear of line of lots Nos. 14 and 15 S. 3-08 W. 100 feet to an iron pin; thence S. 88-48 E. 189.9 feet to an iron pin on the Western side of McDaniel Avenue; thence with McDaniel Avenue N. 9-35 E. 100 feet to the point of beginning. This property is conveyed subject to the following building restrictions:

- (1) The above described Lot shall not be sold, leased, or otherwise disposed of to persons of African descent.
- (2) The above described property shall be used only for residential purposes.
- (3) No building shall be erected on the above described Lot nearer than thirty-five (35) feet to McDaniel Avenue.

This deed is made in accordance with an Order of Court as found in Judgment Roll E-2677, Clerk of Court's Office, for Greenville County.
