Township, State and State aforesaid, on Jamison Hill Creek, containing 54.55 acres, more or less, and having the following notes & bounds: Beginning at a stake on Mill Creek and running N. 80. 28' E. 3.50 ch. to a stake; thence S. 8. 6. 36 E. 3.12 ch. to a stone; thence S 40. 45 E. 13.3 ch. to a stone; thence S. 40. 20 E. 16.05 ch. to a stake; thence N. 68. 10 E. 4.35 to a large P. O. Box; thence N. 7. 20 W. 22.16 to a stake; thence N. 10. 20 E. 8.67 to a stake; thence S. 79. 45 W. 15.26 to a stake; thence N. 6. 36 N. 7.45 E. 7 to a stake; thence S. 64. 32 W. 5.70 ch. to a stake on Mill Creek; thence with Mill Creek 13.00 ch. to the beginning. Bounded by lands of B. P. Campbell, B. G. A. Greenville & state, Mill Creek, Margaret Stewart, P. O. Barnett, B. S. Tallant and the Shields, and being the same land owned by Margaret A.
