Bondholders Corporation a corporation duly or-  
ganized and existing under the laws of the  
State of Delaware, taking on of full and place of  
business at #90 West Street, New York, New York, the  
receipt whereof is hereby acknowledged, have  
granted, forgiven, sold and conveyed and by  
these presents do grant, forgive, sell and convey  
unto the said National Bondholders Corporation, the  
following described real estate:

All that certain piece, parcel or lot of land  
situate, lying and being in the State of South  
Carolina County of Greenville, near the cor-  
porate limits of the City of Greenville, being  
survey and designated as lot No. 24 upon an  
occupation map of the lots on East side of Bradley
