Hudson, of the City of Greenville, in the State of South Carolina; his promissory negotiable note in the principal sum of Twenty-nine Hundred and thirty-nine Dollars (\$2839.00), secured by a deed of trust on the premises hereinafter described, bearing even date herewith and to be simultaneously recorded; the assumption by him of the taxes and assessments, assessed or assessable upon the remises hereinafter described for the year 1931 and subsequent thereto and all installments of assessments of any kind whenseever assessed, payable during the year 1931, and subdequent thereto; and other good and valuable consideration; the receipt of all of which is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release, unto the said R. D. Hudson,
