C. thence N. 75 W. 94 links to a stake; thence N. 6 E. 1.11 to a maple on the branch; thence S. 65 W. 8.90 to a stone; thence N. 21 1/2 W. 29.30 to a stake; thence N. 59 1/2 E. 19.53 to the beginning corner, containing 61 acres, more or less.
