All that piece, parcel or lot of land situate, lying and being in Greenville County and State aforesaid and more fully described as follows:

Beginning at a stake on J. B. League's line and running thence S. 49° 20' E. 543 feet to a stake on the south bank of Horsepen Creek, thence along the bank of said Creek on the South side of same S. 65° 30' W. 553 feet to a stake, thence N. 30° 30' W. 337 feet to a stake, thence N. 56° E. 651 feet to the beginning corner and containing five and one tenth acres more or less and being a part of the same land conveyed to me by deed of J. B. League dated May 20, 1931 and recorded in my office of R. M. C. for said County in Vol 157 at page 592.
