Beginning on David Street (Park Place), which runs from Widow's Hill Street to the Southern Railway track, just beyond the corporate limits of the City of Greenville, thence S. 48-30 W. 190 feet to an alley, thence S. 41-30 E. 47 1/2 feet to Campbell's line, thence with Campbell's line N. 48-20 E. to David Street, thence with David Street N. 41-30 W. 47 1/2 feet to the beginning corner being part of Lot No 73, parcel no 10 of the Washnet lands recorded in Plat Book 000 at page 266, and being the same lot conveyed to Edla R. Reese under her former name of Edla J. Reese, by Claudine J. Campbell, by deed dated July 23, 1916, and recorded in Volume 8, page 543 of the Official Record for Greenville County.

And the said granting corporation, does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinafter named, and her heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
