The descriptions contained in all the deeds and mortgages above mentioned are hereby expressly adopted as parts of the description herein as fully as though fully set forth in this deed.

The chattels herein conveyed are described as follows.

Cotton gin of J. Hooper, situate on the south side of Easley Bridge Road about three miles from the City of Greenville, in the County of Greenville, State of South Carolina, consisting of the following articles.

(A) Four 80 saw Murray super cleaners, one Murray standard cleaner.
(B) Four 80 saw plain pneumatic ball bearing gin outfit, including the following; four 80 saw gins, four iron speed aprons, four ratchet cleaning rollers, one 370 saw drum condenser, with lint slide and dust and lint flues, four 80-saw iron elevator sections with connections over gins, one valve trip, two ball bearing fans, a thirty foot seed conveyor (Ginch) under gins, a seed elevator and conveyor (Ginch) to seed warehouse; one hydraulic steel clad double box press, with triplex pump and automatic mechanical trumper or packer.

(C) One Fairbanks Morse 192 R.P.M. three phase 22 cycle 2200 volt squirrel cage motor, type B and starter with flexible coupling

(D) All pipes, elbows, parts, fittings and other appliances of any and every sort appurtenant to said cotton gin or used in connection therewith.

This property is conveyed subject to prior mortgages thereon covering the gin outfit held by the Murray Company, recorded in the R. M. C. office for Greenville County, in Chattel Mortgage Book 89, Pages 417 and 419 respectively.
